- 1. War and soil challenges and ways to restore: the impact of military operations on the physical, chemical, and biological properties of soil; assessment of environmental damage and soil degradation, soil monitoring in areas of military operations
- 2. Soil and climate: adaptation of agroecosystems to changes: soil surveys; the role of soils in carbon sequestration and climate regulation; preservation of soil fertility, considering carbon status assessment; climate-adaptive practices in agriculture

Submission of abstracts — until November 10, 2025.

REQUIREMENTS FOR THE FORMAT OF ABSTRACTS

Language — Ukrainian, English.

Length — up to 2 pages (4,000 characters).

The text should be typed in Microsoft Word, Times New Roman font, size 14, line spacing 1.5, indentation at the beginning of the paragraph 1 centimeter.

Materials may contain one table or figure, the titles of which should be placed above the table and below the figure in light font size 14, line spacing — 1.

The table should be filled in with a font size of 12 points, line spacing — 1.

The table should be created in Excel or Word without filling; formulas — in the MS Equation formula editor.

Figures created in Word should be grouped into a single graphic object. All illustrations should be submitted in black and white or in shades of gray.

Abbreviations, symbols, and designations should comply with standards.

The original layout should be in A4 format with the following margins:

top and bottom — 2 cm, left — 2.5 cm, right — 1 cm.

Order of placement of material:

first line centered — title of abstract in **CAPITAL LETTERS** in straight bold font;

the next line — information about the author (authors), namely: initials and surname, academic degree, academic title, name of the organization where the author works, e-mail address (font — italics);

the main text begins one line after the author information. Alignment — across the entire width.

The file name of the abstract must correspond to the first author (for example, Shevchenko O.I.doc)

The text of the abstract is not subject to editing and is the original. The author is responsible for its content.

Materials that do not meet the requirements will not be accepted by the organizing committee.

The collection is planned to be published within a month after the conference.

Each participant will receive a personalized certificate of participation in electronic form.

The conference will be held in English.
